### **UPCOMING EXPIRY OF \$0.20 UNLISTED OPTIONS**

Antipa Minerals Limited (ASX: **AZY**) (**Antipa** or **the Company**) advises that the following unlisted options will be expiring in the near future:

The AZYAAE options were issued as free-attaching options, as part of a placement (announced on 28 August 2023) and a rights issue (announced on 1 September 2023). The AZYAAE options were subsequently issued to placement participants on approximately 20 October 2023 and rights issue participants on 6 October 2023.

The Company notes that following completion of the consolidation of the Company's issued capital on 4 March 2025, where every ten (10) shares were consolidated into one (1) share and every ten (10) options were consolidated into one (1) option, the exercise price of the AZYAAE options changed to A\$0.20 per option and the number of options held by each option holder was reduced by a factor of ten (10)<sup>1</sup>.

The Company has dispatched the attached Option Expiry Notice of Unlisted Options to holders of AZYAAE options, which sets out instructions on how an option holder can exercise their options.
